After much discussion from the public, Mr. Ross Machtan asked to be put in the minutes as being apposed to the bar and grill. Mr. Dick Hebert was present and spoke to the public trying to discuss the type of bar he is desiring to have. After more than fifteen minutes of discussion by the public Wayne Called for the board to make a decision in regards to the license in Question. All Points brought up by the public were possible scenarios with no facts to support them; Wayne Rasmussen made a motion to grant Mr. Hebert the license after he presents the certificate of the state building inspector. The motion was seconded by Steve Pankratz and the motion Carried. The public was reassured that the Liquor license are up for review every June , should there be any problems that were mentioned tonight they will be looked at at that time.
