NO TIRES WILL BE ACCEPTED FROM NON-RESIDENTS. THE CITY OF MARSHFIELD IS NOT INCLUDED IN THIS COLLECTION.EACH RESIDENT OF A SPONSORING TOWNSHIP MAY DROP OFF A TOTAL OF (8) AUTO/ LIGHT TRUCK (UNDER 10:00x 22.5) TIRES AT NO FEE. A FEE OF \$8.00 IS CHARGED FOR EACH ADDITIONAL AUTO/LIGHT TRUCK TIRE (UNDER 10:00 X 22.5) THAT EXCEEDS THE (8) ALLOWED. FEES DUE AT TIME OF DROP OFF. NO SEMI TRUCK TIRES. TRACTOR TIRES OR SKID STEER TIRES WILL BE ACCEPTED. RESIDENTS OF THE SPONSORING TOWNSHIPS MUST PRESENT THEIR RED IDENTIFICATION CARD OR DRIVERS LICESNE TO CONFIRM RESIDENCY.
