

## Information About Your Property Tax - Town of Lincoln - Wood Cty.

Tax payments must be postmarked by January 31, 2026

\*\*\* Mail system has changed, postmarks happen at regional centers, not local\*\*\*MAIL EARLY

**Any payments made as a first installment must be made out to: Town of Lincoln.**

To receive a receipt, send or enclose a stamped self-addressed envelope, or go to Wood County website: [www.co.wood.wi.us/Departments/Treasurer](http://www.co.wood.wi.us/Departments/Treasurer) click on Property Tax search, accept and sign in. Then click on search, found on the left side of screen. From there you can use your parcel number or name & municipality to find your parcel. You can see and print a copy of your bill.

**\*\*NEW\*\* PAY ONLINE option:** Go to the town website <https://tn.lincoln-wood.wi.gov>

Select: **Pay Property Taxes** Button. Search by parcel # or name, add all items you wish to pay for to your cash receipting cart. Enter payment. **Check out!** Print receipt if desired. \*Fees automatically added. Electronic Check fee: \$1.50, Debit Card: 1.5% of the amt charged (min of \$1.95), Credit Card: 2.5% of amt being charged.

**Pay in person options:** Bring your parcel stubs along for proper credit.

Any over payments will be refunded approximately 2 weeks after payment has cleared the bank.

## General Town Information

**Appointed Treasurer & Clerk Position:** The Treasurer position was filled in April 2025.

**Town Board meetings** are generally held on the second Tuesday of each month at 6pm, unless there is an election, then it is moved to Thursday. Located at the Town Hall: 10905 Falcon Road Marshfield, WI 54449

**Garbage and Recycling:** Garbage pick-up is Tuesday unless a holiday postpones it by one day. Recycling is the 3<sup>rd</sup> week of each month and is on Wednesday's. See enclosed schedule or see it posted on the town website.

**Dog license** required for all dogs 5 months or older and should be attached to collar. To obtain a license fill out application form on page 2 of this letter, cost and mailing address are listed on form. Send form and payment along with proof of vaccination (initial or updated from the past year.) Proof of vaccination will be returned to you. A license cannot be issued without proof of vaccine! Alternate method to show proof is to take a photo and send it to the Treasurer phone 715-615-2827 when you mail the payment and application.

If your dog turns 5 months old after March 31<sup>st</sup>, the late fee will not be added, if noted when apply for license.

**Burning Permits** are required in the Town of Lincoln for any open burning. You must speak to one of the firefighters listed. A voice message does not suffice!
